School fees are due in accordance with the financial rules signed by all families, as follows:

I -Admission fee (first registration fee to LGM) before final registration.

Students whose admission fees are not paid in full shall not, in any circumstance, be permitted to attend LGM.

II - Fees payable in September.

III - Annual Tutuion: in 2 paymants, invoice sent in October for the first period, in January for the second period.

However, payemnt may be made in advance at the choice of the family.

Invoices are payable with in fifteen days. In the case of non-compliance with this rule, a procedure of recovery will be investigated with the application of financial penalties.

IV -Fees for exams: for the puplis concerned, no later than the end of January of the year of examination.

The financial regulation stipulates that in case of non-payment, the family is exposed to the exclusion of th student during the year. Students who are not in good standing before next grade are not accepted to the next Back to school
